We look forward to working with each of you and meeting you in person during the SACSCOC Annual Meeting in December here in Atlanta.

PRINCIPLES REVIEW COMMITTEE

The mid-cycle review of the *Principles of Accreditation* is being conducted. You will receive an email this fall with suggested changes and/or additions to the *Principles* for your input. Please be on the lookout for the email in early fall. A final draft of the changes and/or additions will be presented to the SACSCOC Board in June 2023 and the membership will be asked to vote on them at the SACSCOC Annual Meeting in December 2023.

ADVERTISEMENT FOR NEW VPs

In mid-August, we will be advertising for two new Vice Presidents. Dr. Mike Hoefer and Dr. Larry Earvin will be retiring in February and June, respectively. We will send you the announcement as well as post it on our website. If you know of anyone who might be interested in working with the Commission in this capacity, please share the announcement with them when you receive it.

BUDGET

SACSCOC once again had a clean audit and we are in line with spending for the fiscal year that ended June 30, 2022. Our Investment account took a hit as did those of our institutions. The SACSCOC Board approved the 2023 fiscal year budget which included expenditures to refurbish the building (new doors and windows, elevator, etc.), an increase in medical costs, as well as a salary increase for staff.

U.S. DEPARTMENT OF EDUCATION

The National Advisory Committee on Institutional Quality and Integrity (NACIQI) is now reviewing them in preparation for our meeting tentatively scheduled for July 19th.
